Rules of Edisto Memorial Gardens Use

- 1. Cancellation less than two weeks before rental due date will result in forfeiture of one half of your deposit. If you are paying via check, then there will be a thirty (30) day hold before refunding security deposit. Garden rental fees are non-refundable.
- The Parks and Recreation Department will determine the site of the wedding in order to reduce outside interference and avoid disturbing normal activities in the Garden area.
 NO WEDDINGS WILL TAKE PLACE IN THE ROSE AREA OF THE GARDENS!
- **3.** <u>NO DECORATIONS</u> of any type may be attached to the Gazebo, wall or railing in the Centennial Park.
- 4. The responsible party is required to clean up any equipment or litter that was the result of the wedding immediately following the ceremony.
- 5. The decoration of vehicles or the surrounding area will not be allowed in the Gardens. The "noisy get away" should be performed at some other location.
- 6. No Disc Jockey or loud music allowed on premises.
- 7. No grills allowed in Centennial Park.
- 8. No alcoholic beverages will be allowed within the Edisto Memorial Gardens.
- **9.** Wedding guest should park in the upper and lower paved parking lots **ONLY** of the Edisto Memorial Gardens.
- **10.** City policy prohibits the cutting or damaging of roses or other flowering plants in the Edisto Memorial Gardens or other ornamental beds throughout the City.

The undersigned has agreed to rent the facility as listed above. The undersigned agrees to keep the facility in good condition to leave it in the same condition as received. The undersigned also agrees to all the rules and regulations imposed by the City of Orangeburg Parks and Recreation Department in renting the facility and specifically agrees to indemnity and hold harmless the City of Orangeburg, Parks and Recreation Department and its employees for any and all claims, demands, actions, proceedings, judgments, losses, damages, counsel fees, payments, expenses and liabilities whatsoever which the undersigned incurs by reason of the use of the facility. Such indemnity shall also apply and all damages or liability that be attributable to the use or unlawful use of alcohol or other illegal substances during the term of the rental.

This agreement shall be binding upon the undersigned, and this agreement shall be construed in accordance with the laws of the State of South Carolina.

STATEMENT OF RELEASE

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

In consideration of being allowed to participate on behalf of City of Orangeburg Parks and Recreation Department athletic program and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

- 1. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
- 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases. If, however, I observe and any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 4.
